

## PLAN REVIEW:

Each plan review report issued by B & F Technical Code Services, Inc. will identify (in numeric order) all areas of non-compliance and will include the section of the applicable code or codes for reference including local amendments.

## **COMPLETION TIME:**

First plan reviews are completed and returned to you within 9 business days of receipt by our office. Additional reviews for all projects are completed within 5 business days of receipt by our office. Priority Review Service\* guarantees completion and receipt of your review within 3 business days. ('Additional fee required.)

## **CUSTOMER SERVICE:**

Unlimited telephone consultations are free of charge and encouraged for all parties involved in the project. B & F Technical Code Services, Inc. also offers free telephone consultation on general code questions for other building projects.

## FACSIMILE AND ELECTRONIC TRANSMISSION:

B & F Technical Code Services, Inc. provides facsimile service for immediate transmission of plan review reports. If requested, we will e-mail the plan review report to you. Original documents will be shipped to your office. Letters, documents, schedules, calculations and other information may be transmitted to B & F Technical Code Services, Inc. via fax at (847) 490-1476 or bftech@bftechcs.com any time.

## TIPS TO AVOID DELAYS:

- Use our Request for Plan Review Submittal form, available in paper form or on an IBM-compattible disk.
- Submit complete information (please note if any missing information will be shipped at a later date).
- Call B & F Technical Code Services, Inc. with any questions concerning requirements and information needed.
- Submit the names, phone and fax numbers for all appropriate contact people.
- Submit the names and addresses of all people who are to receive a copy of the plan review report. We will fax and ship copies at no additional charge.

## PLAN REVIEW FEES:

B & F Technical Code Services, Inc. charges only **one fee** for each review. All additional reviews and shipping (for municipal building departments) are included in the initial fee. This helps reduce the costs associated with plan reviews and helps with accurate budgeting as it is known from beginning to end what the total plan review cost will be. Building plan review fees are based on the total cubic feet of the building. Plumbing, Mechanical and Electrical plan review fees are determined using the building review fee and a multiplier. Fire suppression (Sprinkler) plan review fees are based on the number of sprinkler heads and the type of system used. Refer to the current fee schedule for cost information.

**Note:** When you are considering the cost of your plan review, it is important to compare and determine what the total cost will be upon completion. Some fees may appear lower initially, but may actually end up costing you more later in additional review fees, shipping costs and delays. When your project requires Building, Plumbing, Mechanical, Electrical and Sprinkler Reviews, do the math paying special attention to repetitive multipliers. Is the multiplier based on the original fee or does the original fee increase with each multiplier? Are additional fees charged for second, third or fourth reviews? Are additional fees charged for each type of review? Is shipping included?

- Q: Our department does not budget for outside Plan Review services. How can we use your services without incurring cost to the municipality?
- A: The municipality need not bear the cost for this service. Most model codes make provision for professional fees to be passed on to the permit holder, architect or developer. We can bill the municipality or the appropriate party directly. And with free Federal Express shipping for municipal building departments, your savings are even greater.
- O: What will the Plan Review reports contain?
- A: Plan Review reports contain proper Use Groups, Type of Construction, Mixed Use Options, Rated Assembly Requirements and a numerical listing of specific areas of non-compliance followed by the section of the referenced code, or a letter indicating the plans comply with the applicable code(s).
- Q: How long will the Plan Review take?
- A: First Plan Reviews are completed within 9 business days of receipt. Subsequent reviews are completed within 5 business days.
- Q: In addition to the adopted code, our municipality has its own amendments. Will they be included in the review?
- A: All state and local amendments provided are used in plan reviews completed by B & F Technical Code Services, Inc.
- Q: Are there any other Plan Review costs, extra charges or fees not listed?
- A: Unless significant changes are made to the plans after the review process has begun, no other fees are charged.

- Q: What if I have plans for B & F Technical Code Services, Inc. to review and need answers in less than 9 days?
- A: We will make every effort to expedite your plan review in situations where there is an expressed urgency. Otherwise, Priority Review Service is available which guarantees you will recieve your completed plan review in 3 business days. An additional fee is required for this service.
- Q: How will we receive the Plan Review report?
- A: Upon completion, our report will be faxed to the municipality (also the design professional and other interested parties when requested by the municipality) then shipped via First Class mail. If you do not have a fax machine, we will ship your report next day delivery at no additional charge. We can also send plan review reports via e-mail, when requested.
- Q: When will our plans and specifications be returned?
- A: All information will be returned when the project is completed. Or, if the municipality prefers and requests it, we can discard the information.
- Q: Should the designer, developer, architect or owner have questions concerning the review, can they contact your office for answers?
- **A:** With the municipality's permission, we can provide free telephone consultation to all the parties involved with the project.
- Q: Can the municipality chose to field verify certain items?
- **A:** Yes, B & F Technical Code Services, Inc. follows the instructions of the municipality.

- Q: What if we have a code question concerning a project not being reviewed?
- As a courtesy to our clients, we will answer any code related questions at no additional charge.
- Q: What if we have a building with a particular problem, but it does not require a full review? Could we fax B & F Technical Code Services, Inc. a sketch for an answer?
- A: B & F Technical Code Services, Inc. will evaluate minimal drawings for our clients and phone you with a response at no charge. If a written report is requested, a fee will be charged.
- Q: How will our plans reach your office?
- A: We offer free Federal Express overnight shipping for municipal building departments. Or, you may send your plans via U.S. Mail, messenger or other delivery service. If you happen to be in the area, you may stop by and personally deliver them.
- Q: What should be included in the plans and specifications submitted for review?
- A: Submit one (1) complete set of construction documents signed and sealed by the design professional which include plans, specifications and calculations. Also, use the Plan Review Submittal form indicating the type(s) of review(s) requested, the code and edition used by your municipality and any local amendments.

- Q: Can a construction project be "fast-tracked" or "phased" where portions of the projects are reviewed as they become available?
- **A:** B & F Technical Code Services, Inc. will do a partial review when sufficient information is submitted.
- Q: How confidentially does B & F Technical Code Services, Inc. handle the construction documents or reports?
- A: The strictest confidentiality is applied to all projects.

  B & F Technical Code Services, Inc. will not release any information to anyone except our client unless otherwise instructed.
- Q: Will B & F Technical Code Services, Inc. perfom sprinkler or fire alarm reviews if they have not performed the other reviews?
- A: Yes, we will perform the services the municipality requests. It is our recommendation that we perform a complete project review. A full set of of building plans is required for the sprinkler review.
- Q: I would like a copy of the plan report emailed to the design professional handling my project. Will B & F Technical Code Services, Inc. send reports this way?
- A: Yes, B & F Techical Code Services, Inc. will send reports via email. You or the design professional can also e-mail us at bftech@bftechcs.com.



## **INSPECTIONS:**

From footing to occupancy, or anywhere between, B & F Technical Code Services, Inc. provides inspection services for structural, plumbing, mechanical, electrical and fire protection systems. Inspections are conducted for new and existing construction of commercial, industrial and single-family homes. Inspections are based on the adopted codes of the municipality, including local amendments and standard industry practices.

## INSPECTORS:

B & F Technical Code Services, Inc.'s inspectors are experienced, certified and/or qualified and licensed where applicable to perform inspections.

### **SCHEDULING:**

Inspections may be scheduled directly with our office between the hours of 8:30 a.m. and 4:00 p.m by the contractor, site foreman or the municipality. Our inspectors arrive at your municipality for instructions or at the assigned job site. If more than one inspection is required, a list of inspections should be submitted to our office in advance for proper scheduling and inspector coordination.

## **INSPECTION RESULTS:**

Upon completion of our inspection, we inform the contractor or foreman on site of the inspection results. Notification is issued in the form of a written field report with the original inspection report submitted to the municipality.

## **VEHICLES AND INSPECTION EQUIPMENT:**

B & F Technical Code Services, Inc. provides our inspectors with vehicles for transportation to job sites. However, when inspection services are required on a daily basis, the city/village may provide a municipal-owned vehicle if available. We also provide our inspectors with all equipment needed to perform the inspection.

## WORKER'S COMPENSATION AND LIABILITY INSURANCE:

All B & F Technical Code Services, Inc. inspectors are covered by our Worker's Compensation Insurance. We also carry full Professional Liability Insurance, and the city/village may request their municipalities be named as additional insured.

## **INSPECTION FEES:**

Inspection fees are based on the total square footage of the building as shown on the current fee schedule.

- Q: My building department does not budget for outside inspections. How can we utilize B & F Technical Code Services, Inc. inspection services without any cost to my municipality?
- A: The municipality need not bear the cost of the inspection. The adoption of the three national building codes and/or the International Code allow the cost of inspections to be passed on to the permit holder, architect or developer. Fees may be billed by the municipality, or B & F Technical Code Services, Inc. will bill the appropriate firm/person directly.
- Q: What types of inspections are B & F Technical Code Services, Inc. available to perform?
- A: From footing to occupancy or anywhere between, we provide inspection services for structural, plumbing, mechanical, electrical and fire protection systems. Inspections are conducted on new construction as well as alterations and additions to commercial, industrial and single-family homes.
- Q: Does B & F Technical Code Services Inc. insure its own staff when inspecting for our municipality?
- **A:** B & F Technical Code Services, Inc. carries full Worker's Compensation as well as Professional and General Liability Insurance.
- Q: Can I be assured that B & F Technical Code Services, Inc. inspectors are qualified to perform my inspections?
- **A:** B & F Technical Code Services, Inc. inspectors are certified and/or licensed to perform inspections. Our staff also has a working background in construction and government.

- Q: My municipality has local amendments to the model codes. Can B & F Technical Code Services, Inc. still help with inspections?

- Q: How do I schedule an inspection?
- A: Inspections may be scheduled directly with our office by phone or fax. All inspection requests must be received by 4 p.m. the day before the inspection.
- Q: How quickly are inspections completed?
- A: Inspections can be completed within 24 hours of the request unless otherwise specified by the requester.
- Q: What do I need to provide B & F Technical Code Services, Inc. prior to the inspection?
- A: A copy of the approved building plans will need to be available at the job site.
- Q: May I contact B & F Technical Code Services, Inc. with questions concerning my inspection?
- A: B & F Technical Code Services, Inc. provides our customers with free telephone consultation to clarify any questions concerning the inspection process and results.

- Q: May our staff accompany B & F Technical Code Services, Inc. on inspections?
- A: B & F Technical Code Services, Inc. welcomes municipal staff to accompany our inspectors. This is an excellent opportunity for training as our inspectors point out code issues to consider.
- **Q:** How is the municipality kept informed?

Listed below are the typical required inspections for commercial construction. Additional inspections may be conducted, depending on municipal requirements.

<b>Typical Inspections</b>	When Performed
<b>Footing Forms</b>	When forms are set, reinforcing installed and secured; before concrete is poured.
Foundation Forms	When forms are set, reinforcing installed and secured; before concrete is poured.
Foundation Wall	After forms are removed, and walls waterproofed, drain tile is installed and covered with gravel, and before foundation is backfilled.
Electric Service	When meter socket and main panel are installed.
<b>Underground Plumbing</b>	When piping located between floor or underground is complete, and before covering is installed. Flushing of underground must be witnessed.
Underground Electrical	When piping located between floor or underground is complete, and before covering is installed.
Concrete Floors	When base is prepared, reinforcing and vapor barriers are installed, and concrete is poured. All utilities must be in place.
HVAC Rough-In	When piping and ductwork is installed and before drywall is installed.
Electrical Rough-In	When rough-in is complete and prior to drywall installation.
Plumbing Rough-In	When rough-in work is complete and prior to drywall installation.
Structural or Framing	Before drywall, plaster, or interior finish is applied. Rough-in of electrical, plumbing and duct work, and all fire stopping must be installed. Inspection per floor required for all uses.
HVAC Final	When system is complete and operational.
Electrical Final	When all work is complete and operational.
Plumbing Final	When system is complete and operational.
Structural Final	When all work is complete.
Fire Protection Systems	When fire protection, detection, suppression and alarm systems are installed, tested and appropriately witnessed, and before these systems are operational.
Periodic	Progress or status reporting for large commercial and industrial buildings between regularly scheduled inspections.

## Single Family Home Inspections



B & F Technical Code Services, Inc. specializes in residential, commercial and industrial inspections. From footings to occupancy, we provide inspection services for new and existing construction based on the model building codes, local amendments, and accepted industry practices.

Listed below are the typical required inspections for single family construction. Additional inspections may be conducted, depending on municipal requirements.

<b>Typical Inspections</b>	When Performed
Footing forms	When forms are set, any required reinforcing is installed, and before concrete is poured.
Foundation Forms	When forms are set, any required reinforcing is installed, and before concrete is poured.
Foundation	When concrete is poured and waterproofed, drain tile is installed and covered with gravel, and before foundation is backfilled.
Electrical Service	When meter socket and main panel are installed.
Underground Plumbing	Before concrete or backfill is in place.
Concrete Floors	When base is prepared, reinforcing and vapor barriers are installed, and before concrete is poured. All utilities and service equipment in concrete must be in place prior to inspection.
HVAC Rough-in	When piping and ductwork is installed.
Electrical Rough-in	When rough-in work is complete.
Plumbing Rough-in	When rough-in work is complete.
Framing or Structural	Before any drywall, plaster or interior finish is applied. Rough-in of electrical, plumbing, and ductwork must be approved before this inspection. An inspection per floor is required for all uses.
Insulation	When insulation is installed prior to drywall.
Final	When all building components including HVAC, electrical, and plumbing are complete.
