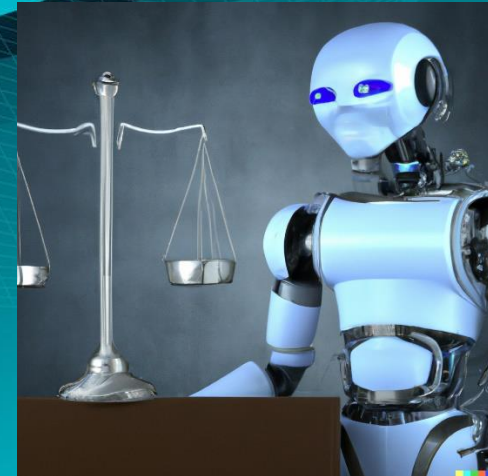

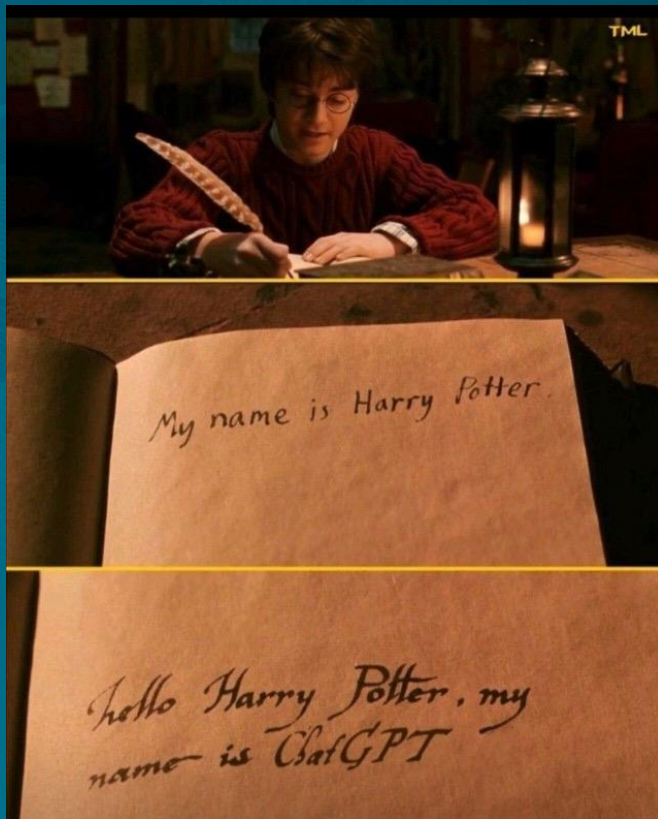

# Artificial Intelligence (AI)


# Prompts (Prompt Engineering)



In the context of language models like ChatGPT, "prompts" are the inputs or queries that users provide to the model, triggering it to generate a relevant response or continuation based on what it has learned from its training data.

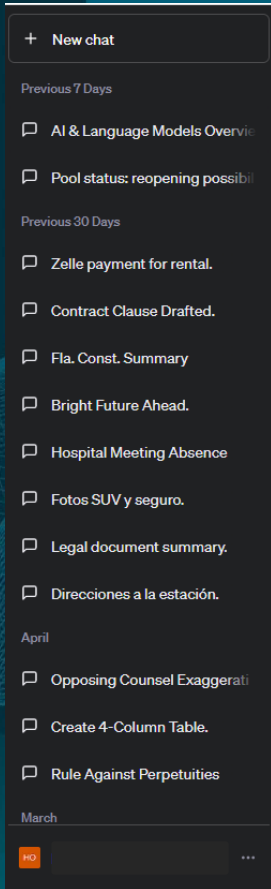

# Search Engine (Google) vs. Reason Engine (GPT)

## SEARCH (Google)

- Crawls/indexes/ranks
- Linear, keyword search
- Helps you find things!  
(information, forms, directions)

## REASON (GPT)

- Trained on internet data; uses logic to summarize, predict, conclude
- It's a conversation – remembers what you type (context)
- Helps you create things

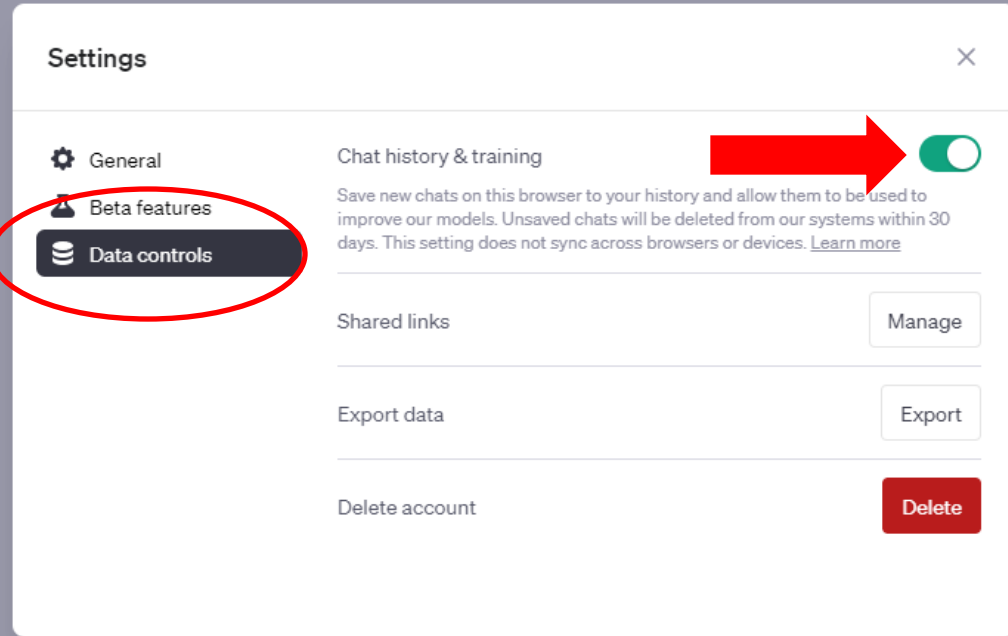
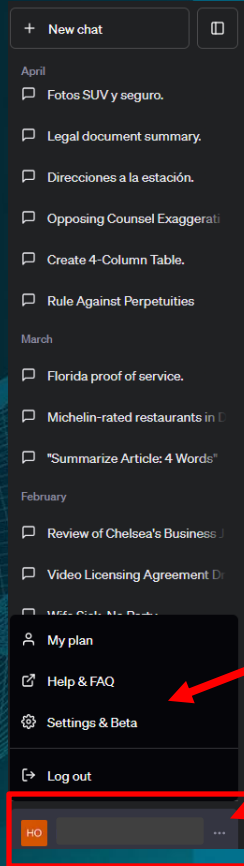
ChatGPT *can* be wrong about information.

# Now let's make a beer

## Instructions:

1. Heat 2.5 gallons of water to 165°F (73°C). Add all the malts, maintaining a temperature of around 152°F (66°C) for 1 hour for the mash process.
2. After 1 hour, rinse the grains with 2 gallons of water at 170°F (76°C). Collect about 6.5 gallons of wort (the water that has been infused with the grains).
3. Bring the wort to a boil, then add the Nelson Sauvin hops. Boil for 45 minutes.
4. Add the Galaxy hops, followed by the Belgian Candi Sugar, and honey. Stir until the sugar and honey are completely dissolved.
5. After boiling for another 5 minutes, add the crushed coriander seeds and star anise.
6. Boil for another 5 minutes, then add the saffron threads.
7. After a total of 60 minutes boiling, turn off the heat. Cool the wort quickly to about 70°F (21°C), using a wort chiller or an ice bath.
8. Transfer the cooled wort to a sanitized fermenter. Pitch the yeast into the fermenter (make sure the wort is cool, as hot wort can kill yeast).
9. Seal the fermenter and fit it with an airlock. Let the beer ferment in a cool, dark place for about 2 weeks, or until fermentation is complete.
10. Once fermentation is complete, bottle the beer with priming sugar (if desired) and cap. Allow it to condition for another 2 weeks to carbonate before drinking.

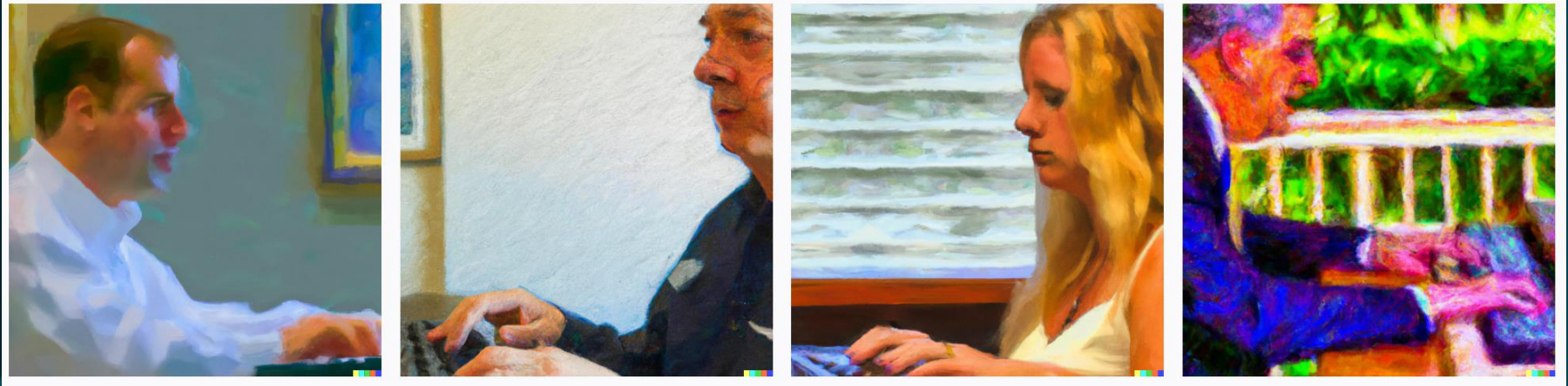
# Takeaway Messages
