### **VCOC** Advocacy in Action 2022

MOAA Advocacy in Action Campaign Topics 2022

- 1. Military Pay Raise at 4.6% per the Employment Cost Index (ECI). MOAA supports the full pay raise for all and will guard against any reductions to fund pay-table overhauls.
- 2. The Richard Star Act. This bill would end an unjust offset faced by tens of thousands of combat-injured retirees who were unable to complete 20 years of service due to their combat injuries. Retired pay is for completed years of service paid by DoD, while disability compensation is for lifelong injury paid by the VA. Two different payments for two different purposes. To reduce retired pay because of a disability is an injustice.
- 3. The Stop Copay Overpay Act. This bill would reduce mental health copays that were more than doubled through military health system reforms. Mental health is increasingly important and getting attention on the Hill due to pandemic impacts and the effects of social media on children's well-being. This issue impacts currently serving families on TRICARE Select, working age retirees and their families.

## VCOC Advocates at Virginia General Assembly 2022

For the past three legislative sessions I have worked to correct an inequity in property tax relief. I consider that there are four groups that deserved tax relief on the basis that if groups above and below the gap had it, it was only "the right thing to do" to ensure that the gap was corrected. Initially, tax relief was granted to what I call group one, three, and four.

Group One: Surviving spouses of those who were killed on active duty. Group Three: Veterans who are rated 100% disabled by the Veterans Administration.

Group Four: Surviving spouses of group three.

This left a gap of surviving spouses whose military spouse died on active duty but was not killed by enemy. This group included many who died in the combat zone by accident, friendly fire, or of a medical condition.

In July 2021, VCOC voted to approve this as a MOAA initiative to bring to the JLC (Joint Leadership Council for Veteran Services), the governor's non-partisan political appointed board. Also, I brought the MOAA initiative forward to the JLC. I edited the white paper I wrote, on the spot, to ensure it was incorporated as a MOAA initiative. I was introduced to Military Surviving Spouse and a member of the NOVA MOAA chapter, Edith Smith. WIth her help, we created a core of 29 surviving spouses to assist with this issue.

In October, working with Edie Smith and Traci Volkie, we gained the support of Delegate Kathy Tran of Springfield to become the patron sponsor of the bill. Also, the JLC listed the initiative as JLC Initiative #2. This gave it significant credibility as one of the top three initiatives.

In January, Delegate Tran's legislation was designated HB 957.

In February, it moved through the committee process in the House, where another delegate who did not understand the importance of a "legal" definition of a "surviving spouse." The change in definition would have forced every single applicant for the benefit to obtain an Attorney General ruling that they would qualify. The House passed this unanimously,

In March, when we took this to the Senate committee system, Traci and I implored Benjamin Hermerding, Delegate Tran's Chief of Staff to restore the original definitional language to that language that I put in the white paper. This eliminated the need for an Attorney General ruling. The amendment passed unanimously, followed by the committee endorsing the bill unanimously.

The bill was signed into lay on April 5th, to go into effect on July 1st, 2022.

## VCOC Reconvenes Quarterly Meetings at Virginia War Memorial

The Virginia Council of Chapters met at the Virginia War Memorial, April 6 2022, Richmond, Virginia. The meeting included two guest speakers, Surviving Spouse Ms. Maria Kelly and Virginia Commissioner of Veterans Services Dan Gade. During the meeting. Ms. Kelly and, Mr. Steve Hornsby, Former Marketing Director of Patriots Colony, Williamsburg were both voted and unanimously approved as honorary VCOC Board members.

During her talk before the board, Ms. Kelly told an impassioned story of her husband, COL Paul Kelly, USA, who died while serving on active duty in Afghanistan.

A New York Times Article dated September 18, 2018 by Patricia Kime, entitled, "Seeing Signs: Proof that her husband is with her, "echoes Ms. Kelly's talk.

"He was known as the Senator, an officer who shook hands with everyone he met, asked thoughtful questions, listened intently to others, regardless of rank. He was a helicopter pilot who flew UH-60 Black Hawks, but he wasn't manning the stick on Jan. 20, 2007, the day his life ended near Baquba, Iraq. He was a passenger, returning to Baghdad after checking on a National Guard combat unit. He was due home to Stafford, Va., in March and had scheduled several vacations — one to visit his elderly parents in Beavercreek, Ohio, another to Germany to celebrate his 10th wedding anniversary. He planned to return to Virginia, continue working for the Guard and, together with his wife, Maria, raise his two young sons to manhood.

Instead, Col. Paul Kelly was laid to rest in two separate plots in Section 60 at Arlington National Cemetery — one that is his alone; the other, a shared grave of commingled body parts belonging to the dozen soldiers who were on the Black Hawk when insurgents shot it out of the sky. Kelly has been gone now for more than 11 years, but his family and friends say his spirit, essence and warmth remain with them on Earth. It's in small signs that they feel his love and know, with unwavering faith, that they will see him again."

Commissioner Gade has both a Master's and a PhD in public policy, having taught at the U.S. Military Academy in West Point, NY and American University, DC. He served at the U.S. Department of Labor for one year, also running for U.S, Senate in Virginia. He has led the Veteran's Coalition for Virginia. In 2022, Governor Youngkin appointed him as Virginia DVS Commissioner.

During his talk, Commissioner Gade highlighted DVS support of three state cemeteries and two nursing homes, with two new homes underway. He also spoke of DVS Veterans claim service support and military spouse support programs for some 109,000 Virginia woman veterans.

Commissioner Gade's top points were threefold. First, the challenges of federal data integration, which are hindered by data privacy issues. With about 730,000 veterans, the Veterans Administration won't tell Virginia the location of Virginia Veterans. Second, the Veterans Administration is not properly assisting with the Virginia Military Survivors and Dependents Education Program, which helps affected survivors and their dependents in obtaining benefits. Finally, he highlighted an increase in suicide among Virginia veterans, noting 70 percent are men over 50, an area which needs further attention.

Commissioner Gade also talked about the "Not Invented Here" Syndrome with DVS, which involves the need for improved partnerships with MOAA, Veterans of Foreign Wars and Wounded Warriors.

Commissioner Gade spoke of "moving the needle" on veterans affairs and a number of areas where DVS needs to improve. He mentioned need for an external evaluation of DVS, such as from a university. He said DVS is recognizing "innovation champions" from within the staff in order to obtain good ideas - to include awarding of up to \$1,500 per quarter in top awards for ideas of innovation. The Commissioner closed by saying he looks forward to DVS being mission partners with VCOC, also big goals from the Virginia Joint Leadership Council (JLC).

## Congresswoman Elaine Luria Hosts First Meeting of the Hampton Roads Veterans Advisory Council

Representative Elaine Luria (VA 02) hosted the first meeting of a newly established Veterans Advisory Council on April 25, 2022 at her Virginia Beach Town Center District Office. The purpose of the Veterans Advisory Council is for members to learn about major progress, successes, and initiatives in the community, also hear updates from council members and for Congresswoman to update stakeholders on her priorities and accomplishments in Congress.

### A Will?

Many people postpone writing a will. Maybe it's because we don't want such a tangible reminder of our mortality. Or perhaps we view the process as relinquishing the ownership of our property. Whatever the excuse may be for putting off the drafting of a will, many people do not realize that writing one actually prevents what is feared. In fact, a will may be the most important document that you ever write, because it allows you to select the persons who will receive what you own when you die. If you don't have one in place, you cannot select the recipients of your property and the state will determine how your property is divided.

What is a Will?

In simple terms, a will is a legal document that dictates how you want your assets to be distributed after you die. It's a fluid document because it has no effect until you die—you can change it whenever you want. To be valid, however, the document must comply with several requirements under state law— the number of witnesses, whether it must be typed or handwritten, and others—all of which are fairly standard state to state and very easy to satisfy.

A will includes specific directions on how you wish your estate to be distributed after your death, including provisions for any tangible personal property that you may own—jewelry, furniture, and the like— well as naming guardians for any minor children. It also indicates what sources will be used to pay any estate taxes and debts that are due, and it names an executor who will be responsible for the settlement of your estate. It ends with your signature, the signatures of required number of witnesses, and typically a notary public's oath about the validity of the various signatures.

Why do I need a Will?

Any type of person— married, divorced, single, childless, parent, in good health, in bad health— should have a will for the simple reason that without one, you cannot determine who should receive your property. Each state has a default plan for how

property must be distributed if you die without a will, with the default (and mandatory) scheme depending on your marital status, whether you have children, if you have any living parents or siblings, and other criteria. Furthermore, even if you die with no living relatives, the state will not permit distributions to a friend, a favorite charity, or any non-related person. Instead, the property will most likely end up going to the state.

No Will?

If you die without a will—known as intestate—the local court must monitor the estate's administration even more closely. This is because the court—not a will—provides all of the authority to act. The administration and closing of the estate generally requires more court involvement, often more publicity, and definitely more red tape.
