Due to lack of doctors in over 30 countries there are midwives who use their beliefs to heal. Therefore, millions of women need serious help to protect their future newborns from diseases created.

"An old superstitious practice in some of the third world countries to stop the bleeding from an umbilical cord is to take dirt from the ground and rub it on the umbilical cord," said Joan

O'Connor, a Key Club coordinator.

The dirt can cause serious health issues, continued O'Connor, for both the baby and the mom and can ultimately result in their deaths. By giving a pregnant mother a vaccination, she and her child will not be at risk of dying from neonatal tetanus. Three shots cost only sixty-seven cents. With boxes from Trick-or-Treating for UNICEF, Key Club members ask for donations to help raise money in providing these women with shots.

As the Holidays approach, Kiwanis International and Key Club will be holding food drives and giving turkeys away for Thanksgiving.

Whether it is making families happy for Thanksgiving or saving a mother and her newborn's life, Kelly High School's Key Club and Kiwanis International has had a great impact in our community and all around the world.


