## A Teachable Moment

Earlier this week MIGOP General Counsel, Mike Bishop, joined the new, bipartisan, anti-election integrity group Democracy Defense Project. Bishop joins establishment political swamp creatures like former Granholm Lieutenant Governor John Cherry and RINO Republican Governor John Engler in "combating election misinformation"—an effort to attempt to convince voters our election system in Michigan is safe and secure, when the reality is the Michigan voter rolls are filled with ineligible voters and many other extreme vulnerabilities such as the lack of requirement to have ID to vote absentee.



A former U.S. Rep, Bishop is the RINO Republican lawyer tapped by Patriot Act Pete to handle MIGOP state party's legal issues. Yet, he is now part of the Deep State mop up effort to assuage the electorate of concerns over corruption. Court-appointed Pete Hoekstra and his MIGOP regime have been telegraphing their anti-election integrity intentions for months. In one of his first acts since taking office, Pete removed the chair and three key members of the MIGOP Election Integrity Committee and dropped the word "integrity," changing its name to simply "Elections" Committee. His core supporters on the State Committee are busy right now attempting to reinstall black box machine voting at the MIGOP State Convention in March, when we elect the new party chair and various other critical positions.

And it's not just at the state party level. Pete Hoekstra's allies in key counties and districts appear to hold the same antipathy to what the GOP base fiercely holds as a top tier, core principle— ELECTION INTEGRITY. For example— last December, when a Royal Oak recount petitioner's research team uncovered dozens of voters whose votes were not counted (they were absent from the city's official, final, certified List of Voters) an investigation by the Oakland County Board of Canvassers was requested by the petitioner. His legal/research team provided the Board with a detailed brief outlining the high likelihood of voter disenfranchisement through either error or fraud.

The bipartisan Board, composed of two Republicans, appointed by County GOP Chair Vance Patrick, refused to bring any of their broad, statutory powers of investigation to bear, despite being informed by the petitioner that the evidence met the test of probable cause. This was the opinion of former Royal Oak City Attorney, Chuck Semchina, who was once an assistant prosecutor for the County's famed L. Brooks Patterson. The petitioner's lawyer reached out to Vance Patrick to enlist his support, but to no avail. The Republican canvassers ignored the evidence and voted with the Democrats. This outcome is par for the course leadership in today's RINO/Globalist-infiltrated Michigan Republican Party — until we stop it.

This is not a new phenomenon. We can go back to 2021 when a certain outspoken, out-of-stater called J.D. arrived in a tiny town in D-5 and began preaching far and wide about the evils of computer voting and the power of the delegates. He travelled the state teaching Roberts Rules and charged a hundred bucks a pop. But when grassroots delegates in Kalamazoo were removed without cause or due process, he was strangely silent. Once he was handed the District 5 Chair, he set aside his pro-delegate, anti-election machine rhetoric and is now supporting Pete Hoekstra's push for black box voting machines at the state convention.

And it's not just the machines. Last month, at the chaotic MIGOP Convention in Flint, one of Deep State Pete's inner circle, 11th District Chair Bill Rauwerdinck, furiously opposed attempts by a delegate from his district to video tape the 11th District's Convention vote count, where his wife was one of the tellers -- in a race Bill himself was a candidate. State Committee member Braden Giacobazzi rallied to the videographer's support. He was a plaintiff in O'Halloran v. Benson, which was being decided that very month in the Michigan Supreme Court. Among the issues was whether or not challengers could video record inside AV counting boards. Giacobazzi was stunned at the irony of his having to fight against his own state party's defense of the same stance on videos of vote counting as the Democrats he was opposing in court.

Infiltration of leadership at all levels of the GOP is clearly a massive priority to competent enemies of God and country. It should be expected that these globalist GOP-imposters will oppose and obfuscate any serious attempts at securing our elections. The above election "factcheck" organization that Mike Bishop has joined, can be fully expected to coordinate with state and national media, which will wage political war on election integrity activists struggling to mitigate the feared effects of systemic election corruption. This is what we constitutionalists refer to as "Dem-RINO-media synergy." Until RINO-backing, grassroots, Michigan Republicans realize they're being played by these imposters and rise up to stop it, the trajectory of state and national ruin will continue to jeopardize the future for our children and grandchildren.
