From a District 11 Poll Watcher: "Two years ago at the last state convention, I filmed the whole D11 tallying process without interference. D11 chair Bill Rauwerdink was present. This year, MIGOP admin Stuart Foster asked me not to film the tallying. I asked him if there was a rule about it. He said no. Then his sidekick "Dennis" volunteered to stand in front of my camera to block me and he remained there for an hour! Furthermore, we requested that Ann Rauwerdink not be a teller in an election in which her husband was on the ballot for presidential delegate. Some of our poll challengers were also on the ballot and they did not have relatives who were tellers. Ann Rauwerdink improperly instructed elector candidates who were poll challenging their own election to stand further away than other candidates' poll challengers for example or herself. She then certified her own husband's election! This poor and preferential judgment demonstrated that she should not be a teller in her husband's election.
