Payment

Payment is due at the time of service unless otherwise agreed upon in writing. Pricing is based on factors such as location, service type, and complexity of the case. These details will be discussed and agreed upon during the scheduling process. We do not bill insurance directly. Clients are responsible for seeking reimbursement through their insurance provider using the superbill provided. Late or missed payments may result in the suspension of services.

Required Documentation

All required documentation, including intake forms and consents, must be completed and submitted prior to the scheduled session. Failure to provide these documents may result in delays or rescheduling of services.

Cancellations and Refunds

Appointments cancelled with less than 24 hours' notice may be subject to cancellation fee. Refunds are not available for completed services. If Live Meaningfully OT is late to an in-home appointment due to unforeseen circumstances, the session will still be completed in full, and the cost remains the same. If Live Meaningfully OT needs to reschedule due to unexpected events, we will notify you as soon as possible to coordinate a new appointment time. No refunds will be issued to digital products - we truly believe in giving more than receiving and each of our products and services is designed by keeping this core principle in mind.
