#### Wanting to apply for a grant? Here are some tips!

- 1. Applications take time.... Prepare in advance
- 2. Make sure your SAM and GATA accounts are up-to-date.
- 3. Some grants require ordinances and policies, so be ready to put them in place.
- 4. Choose projects that are consistent with local plans.
- 5. Do your research! Know your utility rates, assets, or anything that may apply to the grant you are pursuing.

#### Revolving Loan Fund

Looking to open a business? GWRPC provides low interest loans to area businesses to create or retain private sector jobs. Loans can be between \$10,000 and \$300,000, with one job created per every \$30,000 in loan funds.

## **Lawrence County Receives Grant Award**

Greater Wabash Regional Planning Commission assisted Lawrence County with an Energy Transition Community (ETC) Phase I grant application in March. In late May, the Illinois Department of Commerce and Economic Opportunity, through their funding criteria and formula, selected Lawrence County to receive an ETC award of \$83,406 to help address the economic and social impact of the community's plant/mine retirements. Phase II of the application involves public comment and participation, and that application packet is due at the end of July.

## **Energy Efficiency and Conservation Block Grant**



The Illinois Environmental Protection Agency Office of Energy is offering a 3rd and final round funding opportunity to municipalities and counties for the development of local strategic energy or climate action plans through the U.S. Department of Energy (US DOE) Energy Efficiency and Conservation Block Grant (EECBG) Program. Such plans can help qualify units of local government for future project funding.

These funds are available to municipalities and counties only. Grant awards range from \$25,000 to \$150,000. Cost match is not required. Please note- any unit of local government eligible to receive US DOE EECBG Program Formula Grant or Voucher funding is not eligible for funding through this state program.

## **OSLAD Opening July 1st**

The Open Space Lands Acquisition and Development (OSLAD) grant program is set to begin July 1st.

OSLAD provides funding assistance to local government agencies for the acquisition and development of land for public parks and open space. The program is administered by IDNR. Projects vary from small neighborhood parks to large community parks and nature areas.

Applications will be due September 13th, 2024.



## **Public Infrastructure**

#### **Community Development Block Grants**

**CDBG** Project Requirements

- 1. Meet Low or Moderate Income Requirements
- 2. Document a threat to health or safety
- 3. Have the proper permits. To have the proper permits, an engineer must be hired, surveys must be completed, and permits must be submitted and received.

In order to submit a CDBG application, the applicant must meet these criteria. In previous years, applications not including proper permits would lose points but could still be selected for awards; earlier this year, however, Illinois DCEO announced any application without proper permits moving forward will be thrown out and deemed **Do Not Fund**.

We recommend planning for applications a year in advance to be sure they can be completed and submitted on time. In the most recent cycle, applications were submitted for Albion, Grayville, Bridgeport, and Noble. Contact Jeff Vaughan with questions about starting a CDBG application for this year!

## **FEMA Hazard Mitigation Plan**

#### What is Hazard Mitigation?

Hazard mitigation is a sustained effort to reduce or eliminate the long-term risk to life and property from natural hazards. It's an ongoing process that can take place before, during, and after disasters. The goal of hazard mitigation is to break the cycle of damage and repair in hazardous areas, and to help communities recover more quickly from disasters.

## **Illinois Law Enforcement**

#### **COPS Hiring Program**

The COPS Hiring Program (CHP) is a competitive award program designed to provide funding directly to law enforcement agencies to hire and/or rehire additional career law enforcement officers in an effort to increase their community policing capacity and crime prevention efforts.

Anticipated outcomes of the CHP program awards include engagement in planned community partnerships, implementation of projects to analyze and

assess problems, implementation of changes to personnel and agency management in support of community policing, and increased capacity of agency to engage in community policing activities.

Deadline June 12, 2024.

#### **ILEAS Less Lethal Alternatives Grant Program**

The Illinois Criminal Justice Information Authority (ICJIA) has posted a Notice of Funding Opportunity (NOFO) for the Less Lethal Alternatives for Law Enforcement Grant. As the name implies, this State-funded grant is designed to offer law enforcement officers alternatives to the use of force by providing less lethal tools and training. The focus is on Conducted Energy Weapons in the form of the Taser 7 and 10, and support training on topics such as deescalation, cultural competency, trauma-informed response, and more.

#### **Federal Broadband Updates**

#### American Rescue Plan Act (ARPA)

Reporting for Coronavirus State and Local Fiscal Recovery Funds (SLFRF), a part of the American Rescue Plan, is due at the end of April. Entities who have not utilized all of their ARPA funds must obligate those funds by December 31, 2024, and funds must by expended by September 30, 2026 for Surface Transportation and Title I projects. For all other eligible uses, funds must be expended by December 31, 2026.


