General Business Meeting March 13, 2009 Toftrees Golf Resort & Conference Center State College, PA

I. Introduction

The March 13, 2009, Business Meeting of the County Chief Adult Probation and Parole Officers' Association of Pennsylvania was called to order at 9:02 a.m. by Executive Director, W. Conway Bushey.

II. Presentation

Judy Hogaboom and Tracey Allshouse, Internet Probation and Parole Control, Inc. spoke about their program as a tool to assist Probation Departments. Rick Parsons spoke of how useful they have been in Montgomery County. The cost of the program is \$24.00 per defendant.

Gary Holland provided a DACUM overview. He discussed trainings for job functions. During the sessions every piece of a probation officer's job is analyzed using the Story Boarding process and focus groups. They are now looking to hear from management level and use the information to revise and train the right material for BTA. Motivational Interviewing was brought up and led to a lively discussion. It may be added to the 4th week of BTA.

III. Agency Updates

AOPC-no report

CCAP – The County Commissioner's Association is in the process of seeking funds from PCCD for a data quality study.

PCCD-no report

Sentencing Commission – Carrie Peters discussed the 6th Edition Revised Guidelines. She provided an updated list of training dates. March 15th is the deadline for 2008 sentencing data going into SGS web. Carl McKee asked about how to get data on defendant's prior arrests. Carrie replied that since it is new it would be difficult but may be able to be provided on a future date.

PBPP – Probation Services – Bill McDevitt – Bill updated on the Governor's Advisory Committee on Probation, specifically on Destruction of Property. The 4th Edition is currently on hold in Appropriations. There are currently only (5) counties not providing data to the Board electronically. Bill also informed the Chiefs that there

is a reduction in training funds this year. The Grant-In-Aid for 2009-2010 of \$19,028,000.00 should not be reduced due to increased caseloads. Mike Pottieger asked about information on fines and costs be provided by CPCMS. Bill advised that the AOPC was unable to provide this information at this time.

Interstate – Margaret Thompson – Margaret reported on ICOTS and that there are now 34 counties under the new system. Their training scheduled for end of February was filled in two (2) days requiring a second day. There will be an additional training April 27th or 29th in Mercer County. Margaret reported that Webex might be possible in six (6) months. She also stated that the BTA Interstate training is still available. There will be a second Legacy data dump into the system. Gary Holland reported that video conferencing/Webex for ICOTS training. He also reported that Motivational Interviewing Training would not be disturbed by lack of funding. Gary stated that back time and credit time might become available with John Holt.

FETC – Todd Burns – Todd announced that it was ok to take repeated in-service courses if necessary. They are in the process of reviewing Basic Training Courses for 2010. They may expand to two (2) full weeks and asked for any recommendations. Todd announced that there would be an in-service in Fort Indiantown Gap April 6-10th and will continue through October. Todd reported that they have 30 days to work out regulations (17 differences) or they will have to start over. Todd reported that Requalifications Failures Policy to follow.

Conway discussed the Pew Study, One in 31-Long Reach of American Corrections. Also, the calendar of events was reported.

- **Training** Rich Kipp reported that an e-mail would be sent to all chiefs in regards to an on-line survey for possible Chief's Trainings. Hope to set up Modules for annual conference and regional trainings.

- Intercounty It was discussed and agreed that any case three (3) months or over must be accepted for supervision. There was a discussion about the Southeast 10 County Region and the success in opening regular lines of communications and that counties need to work together.
- **Program** Mike Potteiger discussed having 90-minute training segments as opposed to 1½-day segments. Ted Johnson reported that there will be a National Reentry Conference in Pittsburgh on April 5-8, 2009. Ethics was discussed as possible training topic for the annual conference. Also, discussed were fishing, golf, massages and the traditional ideas for entertainment at the conference. Chris Murphy briefly reported on the Parole Guidelines Committee.

The salary disparity between line staff and supervisors was revisited. Conway stated that he would conduct a survey and submit his findings to Bill McDevitt. It was discussed to ask the Board for assistance in regards to Salary disparity and Grant-In-Aid.
