**General Briefing:** Per COVID-19 guidelines for safe distancing, the general briefing will be printed and posted in several areas.

Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title, and then they cannot enter the Instinct test. Dogs completing their RATN Open in the next trial can still participate in Instinct for the remainder of the event weekend. (This is up to the handler and not required). All entries must be accompanied by an entry fee to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. Refunds minus processing fees are available upon request until the closing date, no refunds after the closing date. Make checks payable Olympic Kennel Club & send with entry to the trial secretary. MAIL-IN ENTRIES ONLY accepted.

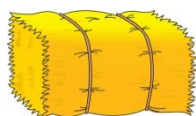

## Safety

All Dogs must be on a short leash and under control while on trial grounds except while showing. FLEXI LEASHES ARE NOT PERMITTED INSIDE ANY BUILDINGS. No e-collars or head-halters allowed. There is no smoking in the barns or within 50' of any building entrance. Please pick up after your dog and dispose of waste in appropriate containers outside of the barns. Failure to pick up after your dog is grounds for misconduct hearing and possible loss of qualifying scores. The barn is covered, but not climate controlled, plan accordingly. There are limited crating areas in the barn. Trial grounds encompass the livestock barn and blinding area, the restrooms and designated parking & overnight areas, and a 50' buffer around all listed areas.

## Running Order

Dogs will run in order of height, with dogs handled by the same person separated into different blinds. The class order is announced/emailed when trial closes.

## Awards

Ribbons will be awarded for first through 4th place in each height division for A level class and height combined B level classes. Dark Brown qualifying ribbons will be awarded for all qualifiers in the regular classes, crazy 8, and the Instinct test. All awards must be picked up that day; mailing is not an option.

## Bitches in season

Are eligible for entry but will be required to be kept separate from all other dogs and will run in panties at the end of their class/trial. If bringing a BIS, please inform the trial committee and all exhibitors at the judge's briefing.
