Coolest Products Made in Illinois

With almost 100,000 votes cast, the field of contenders competing in fourth annual "Makers Madness" contest has been narrowed to the Top 16. Hosted by the Illinois Manufacturers' Association, the bracketstyle tournament allows voters to decide which product is The Coolest Thing Made in Illinois.

Presented by Comcast Business, the competition celebrates manufacturers who have long served as the backbone of the state's economy. They produce nutritious food and snacks to life-saving vaccines and medical treatments to electric vehicles, sporting equipment and structural products like steel, rebar and motors to chemicals and high-tech gadgets used for national defense and energy to power homes and businesses. A recent study found the total economic impact of manufacturing in Illinois estimated to be between \$580 billion and \$611 billion every year, the largest share of any industry to the state's Gross Domestic Product. Nearly 250 unique products from across the state were nominated for the 2023 title. The top four vote-getters from the initial round of voting are the Accuchiller NQ Series Brewery & Distillery Glycol Chiller manufactured by Thermal Care in Niles; the Jessup Safety Track Recon by Jessup Manufacturing in McHenry; Hummer EV Headlights by North American Lighting in Salem; and the Bison PowerSTAR Coffee Gearmotor Roasting made by Bison Gear & Engineering Corp in St. Charles.

The Horizons4U pro-gram was launched last spring, allowing employ-ees who already work for the district to pursue a career in teaching and several other professions. Horizons4U is a collabo-rative effort between neighboring universities neighboring universities and colleges to cover the

districts maximum flexibility to use the funds in innovative, ways, such as offering signing bonuses, housing stipends, downpayment assistance, or loan repayments; paying tuition and fees or provid-

ing residencies or apprenticeships; and sustaining current teachers by pro-viding materials, supplies, coaching, and school culture supports. ISBE will utilize \$6 million in federal funds to

procure a multimedia advertising and marketing firm to develop and implement a statewide teacher recruitment cam-

Radon Action Month Features 2 Contests

Radon is a naturally-occurring element which is undetectable from human senses. The Illinois Emergency Management Agency is urging residents to take time to test their home as part of 2023 Radon Action Month.

"This odorless, color-less, tasteless gas is found in the air we breathe in buildings, homes, offices, said IEMA Director Alicia Tate-Nadeau. "If not properly addressed, high lev-els of radon can cause major health concerns." It's estimated more

than 1,100 people in Illidevelop radon-renois lated lung cancer each year. Tests can be purchased at most hardware and denartment is recommended to conduct one short-term and one long-term test to ensure consistent readings. Should you find higher readings, contact IEMA for information about a licensed mitigation professional. The IEMA and Lung Association in Illinois are announcing the continuation of two statewide contests that encourage students to use their creative talents to promote radon awareness among young people. The Radon Video Contest asks high

school students to create a 30-second commercial style video, while the Radon Poster Contest asks middle school stu-dents (9-14) to create a poster that will encourage people to test their homes.

Deadline for entries is March 18th. Poster contest winners will receive \$200 for first prize, \$150 for second and \$100 for third. Video contest winners will receive \$1,000 for first place plus \$300 for their school; \$750 for second plus \$200 for their school; \$500 for third plus \$100 for their school and \$250 for Honorable Men-



Nyala Calf Born at Brookfield Zoo

One of Brookfield Zoo's newest additions-a 3month old female nyala has been behind the scenes bonding with her 4-year-old mother, Zola since Dec. 5th. Just recently, she has been given access to their outdoor habitat with the rest of the herd that includes Hamilton, the calf's sire; Merry and Leah. The pairing was based on a recommendation from the Association of Zoos and Aquariums" Species Survival Plan.

Both male and female nyala reach sexual maturity at about one year old. Peak breeding seasons are in the spring and fall. Following a 7-month gestation, the female gives birth to usually one offspring.

Males are larger than the females and have the long inward spiraling horns. Both sexes have vertical white stripes, although they are more prominent on the females.

While nyala are considered common in southern African countries, the species has threats to its population. These are habitat loss due to agriculture and cattle grazing and hunting.

Currently, there are nearly 90 nyala in 16 accredited North American zoos. The species is fairly new to Brookfield Zoo, the first arriving in 2019.
