Rebecca DePew, Judge, Bell County Court at Law No. 3. spoke to the Temple Founder Lions this week.

Judge DePew received her Bachelors degree from Texas A&M Commerce in 1989 and, after being awarded her Doctor of Jurisprudence Degree from Baylor University School of Law,

was licensed to practice law in Texas in 1992. Judge DePew was elected to the honor of serving as Judge of the Bell County Court at Law No. 3 and took office January 1, 2011. She is currently serving her second term of office.

The County Court at Law No. 3 has seen a number of changes. Judge DePew now hears all of the juvenile cases and continues to hear criminal cases which include the mental health docket as well as the rocket docket for repeat misdemeanor offenders. The Judge also handles the Veteran's Court for Bell County as well as the Drug Court for Bell and Lampasas Counties.
